ACNO Youth Artist in Residence Program Description

The 2017 Youth Artist in Residence (YAR) is open to all aspiring artists age 16-18 living within School District 22. The ACNO will award 1-2 students a residency annually. The selected artist(s) will be provided a dedicated studio space at the Vernon Community Arts Centre, have access to administrative and artistic support, access to facilities and equipment during open hours, an honorarium to purchase materials and supplies, and a solo* art exhibition/show. The residency for 2017 runs **Monday, July 17th – Friday, August 25th**. The application deadline is **June 30th**.

The objectives of the YAR program are to give young aspiring artists the opportunity to:

- explore and develop creative processes
- discover and learn a variety of art medias and techniques
- interact and connect with artists and arts organizations/groups
- create a body of work to be exhibited in a solo art show

Selection Process

A committee panel of local arts & cultural professionals from various disciplines will review the applications and choose the finalist. The selection is based on artistic integrity, ability and demonstrated support to participate in the YAR program. Selections are made without regard to race, religion, gender or national origin. Once the selection has been made and the Agreement Letter is signed by all parties, the youth artist will begin the *Artist's Orientation* period.

Artist's Orientation

The Artist's orientation period will consist of the following:

- a tour of the facility and YAR studio
- an introduction to ACNO organization staff and "regular" member artists
- training of facility equipment (where applicable)
- being assigned a private locker to secure materials, supplies, and valuables
- setting up a schedule to meet with the manager for progress checks
- creating a set of goals to include: learning objectives, quantity of work to be produced, etc.
- making a list of materials and supplies needed to achieve goals
- shopping with supervisor to purchase materials and supplies

Artist's Residency Terms and Conditions

The Artist agrees to comply with the following terms and conditions:

- the artist has access to the studio when the VCAC is open for business
- the artist will be in the studio for a minimum of 10 hours/week
- the artist will volunteer at the Arts Centre for a minimum of 3 hours/week assisting with classes or helping studio technicians
- the artist may audit a workshop or class on the approval of the instructor and supervisor
- the artist may request flexibility in their schedule if changes occur during the residency; the supervisor retains the right to decline these requests
- the artist will maintain and follow health and safety practices

Financial Management & Residency Budget

The artist will be responsible for all expenses related to housing, transportation and meals for the duration of the residency. All other financial administration of the Youth Artist Residency revenues and expenses will be the responsibility of the ACNO. The ACNO will provide a \$200 honorarium to the artist for the purchase of art materials and supplies, as well as in-kind contributions, including: supervision, creating and distributing promotional materials, coordinating the Opening Reception, and general administrative duties.

Reporting Protocol

Any incidents or issues will be reported immediately to the manager of the Arts Centre. A final evaluation report will be presented to the ACNO Board of Directors.

*if two artists are selected for the program, the studio space and exhibition/show will be shared.
